

### KCBOR MLS Dues: Billed by email from support@kcbor.com to each Individual MLS Member:

MLS Dues are \$250.00 Semi-Annually. Due 1st of January & 1st of July.

Semi-Annual Dues January – June Billed on December 1<sup>st</sup> of the prior year. Due 1<sup>st</sup> of January.

Semi-Annual Dues July – December Billed on June 1<sup>st.</sup> Due 1<sup>st</sup> of July.

### <u>Proration of MLS Dues if joining month prior to next Semi-Annual Billing Schedule:</u>

\$291.65 If joining in the 6<sup>th</sup> month of the semi-annual billing cycle: \$250.00 next semi-annual billing cycle dues plus \$41.65 (6<sup>th</sup> month of the semi-annual billing cycle amount)

### **Reinstatement Fee:**

Agents who fail to pay their MLS Dues during their semi-annual billing cycle, beginning on the 4<sup>th</sup> month of billing cycle, MLS Member will be required to reapply at the pro-rated amount of MLS Dues and will receive a \$125 Reinstatement Fee.

### **Example:**

**Dues Invoice Emailed:** 12/01/24

**▶ Dues Invoice Amount Due:** 1/01/25

> 10 Day Grace Period: 10% Late Fee Assessed on Invoiced Total Amount Due: 1/11/25

➤ **Deactivate Membership:** If Invoice Unpaid on 2/01/25, (11/2024).

# MLS ADMIN/Secretary MLS Dues are billed to the Broker of Record or to the Agent who has an ADMIN (with Brokers Approval):

ADMIN/Secretary MLS Dues are \$90.00 Semi-Annually Per ADMIN/Secretary. Due 1st of January & 1st of July.

Semi-Annual Dues January – June
Billed on December 1<sup>st</sup> of the prior year. Due 1<sup>st</sup> of January.

Semi-Annual Dues July – December
 Billed on June 1<sup>st</sup>. Due 1<sup>st</sup> of July.
 (ONLY 1 person per ADMIN/Secretary ID)

## <u>SentriAccess Dues are billed by email from support@kcbor.com to each Individual MLS</u> Member:

SentriAccess Dues are billed to *each individual* with MLS only SentriAccess annually.

> \$160.00 July 2024 – June 2025 Billed on June 1st of the prior year. Due 1st of July.

### **Please Note:**

(KCBOR REALTOR® Members receive their Annual SentriAccess for <u>FREE</u> as a <u>BENEFIT</u> of KCBOR membership. \$160.00 Annual Savings)

A 10% late fee will be assessed to MLS Dues, ADMIN/Secretary Dues & SentriAccess Dues if payment is not received by 11:59pm on the 10<sup>th</sup> of the month due. If the 10<sup>th</sup> falls on a weekend or a holiday, the payment will be due the next business day by 11:59pm. (If mailing the payment, please note per MLS Policy post marks DO NOT count as timely payment of dues.)
