New members are defined as someone who has never been a member before or has had a one-year lapse in membership. For example, a REALTOR® member who paid dues in 2024 and decided to be a LFRO or a non-member in 2025 and then decides to rejoin in 2026 is considered a new member because of the lapse in membership with C.A.R. and NAR. The licensee would then be considered a new member and would get the benefit of paying the prorated dues amount plus the \$200 new member fee. Dues are prorated on a monthly basis for new members only.

Renewing members are defined as someone who has paid dues for consecutive years with no lapse in membership. For example, REALTOR® members who paid dues in 2025, are considered a renewing member for the entire 2026 billing year. This means, if they became a LFRO, MLO, or non-member at any point in 2025, and then decide to join as a REALTOR® member later in 2026, they would still be considered a renewing member and would pay the full year dues for both C.A.R. and NAR plus a C.A.R. \$50 late fee if renewing after March 1st.
